



CDR Executive Education Program

This 7-week executive education course, developed and taught by Jennifer Wilcox and Noah Deich, equips participants with the technical fluency, policy context, and practical tools to evaluate, negotiate, and implement high-integrity carbon removal purchases.

It is designed for both corporate and government buyers, as well as emerging suppliers, verifiers, financiers, and philanthropic stakeholders. The course aims to provide a foundational overview of the carbon removal ecosystem, as well as the basics of how to purchase carbon removal with the greatest impact, for those with corporate sustainability and carbon market experience, but without deep experience in carbon removal specifically.

Participants will leave this course equipped to design carbon removal purchasing strategies, source projects, perform due diligence, and negotiate contracts.

Course Format

The course combines weekly 60-minute live sessions (45-minute presentation, 15-minute Q&A), pre-recorded materials, and a homework-guided final project. Class is held from 12:00–1:00 PM (Eastern Time) on Tuesdays and Thursdays. Optional further readings provide additional understanding of the technical and policy aspects of the field.

Course Objectives

- Understand technical and economic fundamentals of CDR
- Evaluate and design procurement strategies, including MRV and co-benefit frameworks
- Explore global policy and equity context in which removals projects operate
- Navigate LCA, TEA, and social impact assessments
- Participate in practical simulation of a CDR contract negotiation

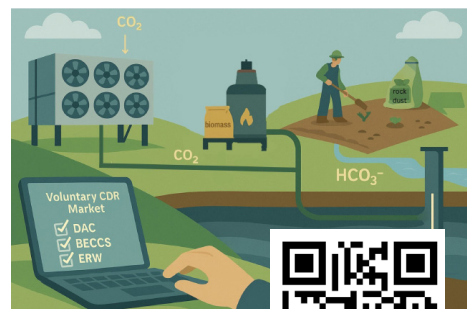
